The Basics:

- · Artist entry is first-come, first-served
- Artists must request a chair or table by April 30.
- Artists may choose to pair table with a chair. Artists can pick up chairs/tables/benches when contacted by Art Reach of Mid Michigan that they are available.
- Furniture must be sanded, primed, painted and coated with a final layer of polyurethane or polyacrylic. (Poly available at Art Reach of Mid Michigan upon artist's request)
- Embellishments may be added to furniture, however, they must fit through doorways.
- No decoupage, stickers, marker, or glue
- Furniture must be delivered to host locations by June 30.
- Furniture is displayed at host locations until July 23.
- Furniture will be judged July 24.
- Votes will be counted, people's choice will be decided and chairs will be auctioned off on July 24.

Trademarked content is NOT allowed. Any entry that infringes upon another's

copy right will be disqualified from the cash prizes.

## A Chair Affair 2015 Guidelines

Revised February 2015

Art Reach reserves the right to remove an item from the competition that does not follow the guidelines established by the Chair Affair Committee. All items are the property of Art Reach and will be returned to Art Reach/their representative on the schedule established by the Chair Affair Committee.

## **Subject Matter:**

All artwork must be the artist's original artwork. Trademarked content is NOT allowed. Any entry that infringes upon another's copy right including but not limited to popular movie, game, and TV characters, trademarked logos, and actors/musicians will be disqualified from the cash prizes. The artwork should be of family appropriate content with a broader appeal. Keep in mind that this is a community event and fundraiser.

#### **Artist Selection:**

Both professional and non-professional artists may sign up to participate in the Chair Affair competition beginning in April by filling out the form online or at Art Reach. Artists will be selected by the committee based on a first come, first served basis. Each artist/school will be allocated only one(1) item unless there is a shortage of artists based on the number of pieces available. By entering the competition, the artist grants permission to Art Reach to reproduce images of the artwork for publicity and marketing purposes. Artists are responsible for the collection and return of the item to the designated locations on the designated schedule established by the Chair Affair Committee. Educators may arrange for delivery of the items by contacting Art Reach or a committee member.

# **Embellishments:**

Embellishments are allowed. Keep in mind the embellishments will need to be weather proofed. Decoupage/stickers/glued items/marker are not appropriate options. While alterations may be made, the item that you receive must be the item returned to Art Reach/Host for the competition. Dimensions of the finished piece must be no larger than 34" across on one side and must fit through a doorway.

## Finishing:

Artists should understand that the items will be displayed outdoors and should be finished appropriately with polyurethane or poly-acrylic for protection from the elements. A brushed on top coat is preferred.

#### Prizes:

First, second and third place prizes will be awarded for Art Students guided by Art Educators-juried and Community Members-juried. A first place prize will be awarded for People's Choice-popular vote.

#### Judges:

Judges are selected solely by the Chair Affair Committee. There will be a minimum of 3 and a maximum of 5.

#### **Silent Auction:**

Items will be sold by silent auction at the end of the competition. A paid receipt must be presented to a member of the committee or Art Reach staff to claim an item. Items should be paid and removed as quickly as possible at the conclusion of the event.
